- March 22, 2022 NSECC issued a revised approval allowing FEP/WSF deactivation to proceed once a Compliance Plan was submitted and accepted.
- NSECC Approval Performance Targets
 - Long-term performance target of 10% compostable waste
 - Not required to meet 10% compostable waste to deactivate the FEP/WSF
 - Removal of white goods and hazardous waste, where visible and can be safely removed

Overview

- June 29, 2022 Compliance Plan was submitted to NSECC
- November 4 and 22 Compliance Plan was updated and resubmitted based on NSECC comments
- November 30, 2022 NSECC accepted the Compliance Plan



Compliance Plan – Performance Audits

- Required by NSECC Approval to be completed quarterly
- 40 samples annually to be collected and sorted
- Sorting categories focused on compostable waste (e.g., food, fibre, leaf and yard waste)
- First year of Performance Audits used to baseline the composition of compostable waste
- CMC representation at all Performance Audits to date and have received all reports

Compliance Plan – Performance Audits

- Four baseline Performance Audits were competed in May 22, August 22, November 22, and February 23
 - \circ % Compostable Waste = 12.41%
 - % Compostable Waste 95% confidence interval ranged from 9.31 to 14.72%
 - \circ Food Waste = 7.16%



Compliance Plan – Schedule

• Per accepted Compliance Plan:

Section 5, Table 5.1: "Within 30 calendar days of completing four Performance Audits, HRM and Mirror NS propose an update to this Compliance Plan be submitted to NSECC, specifically assessing audit results against the Compostable Waste Performance Target of 10% and identifying timelines/milestones to meet the Performance Target (if required)."



Compliance Plan – Schedule

 March 16, 2023 HRM and Mirror submitted schedule to NSECC to work towards the long-term Compostable Waste Performance Target of 10%.

March 31, 2024	Compostable Waste at 11.61%
March 31, 2025	Compostable Waste at 10.81%
March 31, 2026	Compostable Waste at 10.00%
